

## SUN CITY LINCOLN HILLS GARDEN GROUP 2024-2025 SCHOLARSHIP APPLICATION

SCLH Garden Group is offering up to two scholarships for the 2024-2025 academic year as follows:

College, University or Community College Enrollment

Full-time 12-15 units \$1,000

Part-time 6-11 units \$500

**Application Forms** are available on the SCLH Garden Club website: <a href="https://linear.com/lhgardengroup.org">https://lhgardengroup.org</a>. Forms must be completed, signed, dated and **postmarked by March 15, 2025.** 

### **Eligibility Requirements:**

- 1. Must be a California resident with a permanent home address in Lincoln, CA.
- 2. Must be a high school senior enrolled in a public school in Lincoln.
- 3. Must have a 2.75 GPA or higher in order to apply.
- 4. Must be accepted and enrolled in a two or four-year college or university.
- 5. Must be majoring in Horticulture, Floriculture, Landscape Design, Botany, Forestry, Conservation, Plant Pathology, Viticulture, Enology or other plant-related coursework with the intent to pursue a career in that field.
- 6. Photo of Applicant: If selected, applicant must provide a recent quality photo for publicity.

#### **Application Requirements:**

- 1. An essay of no more than two single spaced typed pages is required for all applications. State educational and personal goals including what experiences led you to choose your particular agricultural field of study.
- 2. A list of community service and volunteer work as well as extracurricular activities with verification letters of participation.
- **3. Two letters of recommendation** from a teacher, counselor, professor, or non-family related adult who can affirm your character and accomplishments. Statements from family members will not be accepted. Letters must be signed by the person including a phone number for verification.
- 4. Enrollment at the college or university indicated is required. Enrollment verification will be required prior to fund distribution and by providing your college ID number.

#### **Distribution of Scholarship Funds:**

Awarded funds will be mailed from the Garden Group to the Financial Aid Office of the institution where the student is enrolled. **No funds will be sent directly to the student.** 

The student and the Financial Aid Officer will determine how the funds will be spent: tuition, books, etc. In the event of a change in a student's major to one other than those listed above or if the student withdraws from school, the balance of the funds is to be returned to SCLH Garden Group.

If a student's status changes from full-time to part-time, funds may be adjusted.

The completed application packet must be postmarked by March 15, 2025. Packet must include signed and dated application, essay, letters of recommendation and transcripts.
